The purpose of this Registration Statement on Form S-8 (this "Registration Statement") is for Allot Communications Ltd. (the "Registrant") to register an additional 770,289 Ordinary Shares for issuance under the 2006 Compensation Incentive Plan.

We refer to the Registration Statement on Form S-8 (the "Registration Statement") to be filed with the United States Securities and Exchange Commission (the "Commission") under the Securities Act of 1933, as amended, on behalf of Allot Communication Ltd., a company organized under the laws of the State of Israel (the "Company"), relating to up to 770,289 of the Company's Ordinary Shares, nominal value NIS 0.10 per share (the "Shares"), issuable under the Allot Communications Ltd. 2006 Incentive Compensation Plan (the "Plan").

As special Israeli counsel to the Company, we have examined such corporate records, certificates and other documents provided to us by the Company, as we have considered necessary for the purpose of our opinion. No opinion is implied or may be inferred beyond the matters expressly stated. This opinion letter is effective only as of its date, and we disclaim any obligation to advise of any subsequent change of law or fact.
