## EXPLANATORY NOTE

Effective October 28, 2016, the Board of Directors of Allot Communications Ltd. (the “**Company**,” the “**Registrant**” or “**Allot Communications**”) approved an amendment to the Allot Communications Ltd. 2006 Incentive Compensation Plan (the “**2006 Plan**”) to extend the term of the 2006 Plan by 10 years and to rename the 2006 Plan as the Allot Communications Ltd. 2016 Incentive Compensation Plan (the “**2016 Plan**”). This Registration Statement is being filed to register an additional 250,000 ordinary shares, par value NIS 0.10 per share (“**Ordinary Shares**”), of the Company issuable pursuant to the 2016 Plan, representing an automatic increase effective as of January 1, 2017.

In accordance with General Instruction E of Form S-8, the contents of the Registrant’s Registration Statement on Form S-8 (File No. 333-140701), filed with the Securities and Exchange Commission (the “**Commission**”) on February 14, 2007, as supplemented, amended or superseded by the Registrant’s Registration Statements on Form S-8 (File Nos. 333-149237, 333-159306, 333-165144, 333-172492, 333-180770, 333-187406, 333-194833, 333-203028, and 333-210420) filed with the Commission on February 14, 2008, May 18, 2009, March 2, 2010, February 28, 2011, April 17, 2012, March 21, 2013, March 27, 2014, March 26, 2015, and March 28, 2016, respectively, are incorporated herein by reference and the information required by Part II is omitted, except as supplemented by the information set forth below. References to “we”, “our” or “us” below refer to Allot Communications Ltd. and its consolidated subsidiaries.

Any statement so modified or superseded shall not be deemed, except as so modified or superseded, to constitute a part of this Registration Statement.
